The sector specific models include an unconstrained interest rate strategy, a dynamic commodity strategy and a long/short global financials strategy. The Program is designed to produce returns with lower volatility and a higher Sharpe ratio.

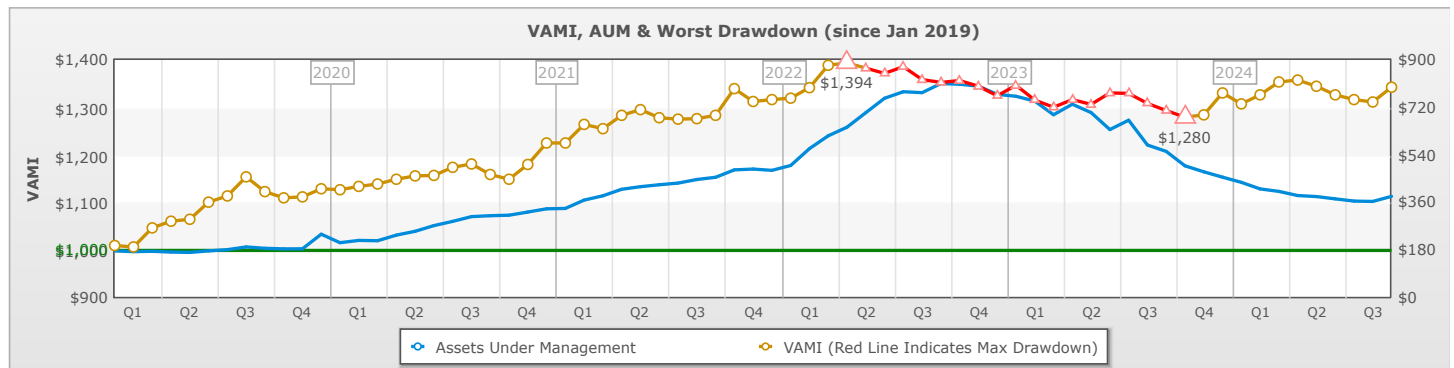
