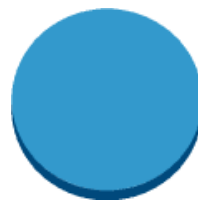

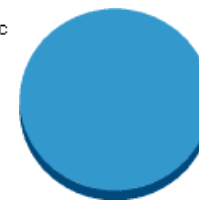

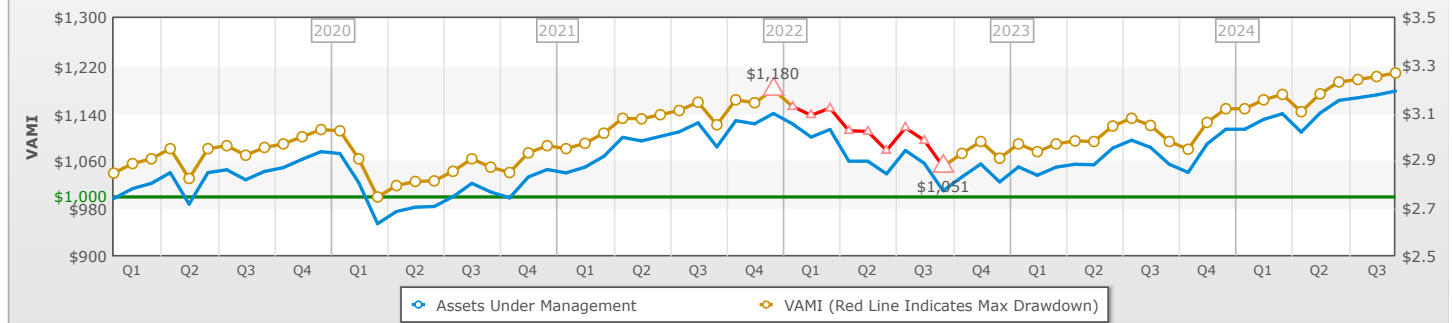


**Market Segment**

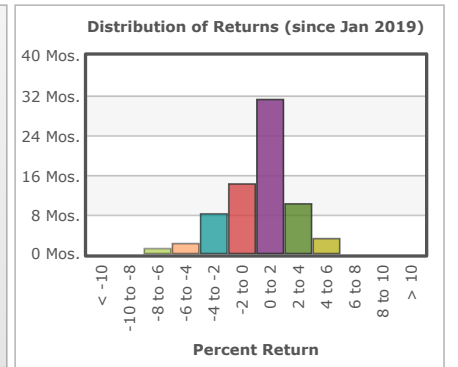
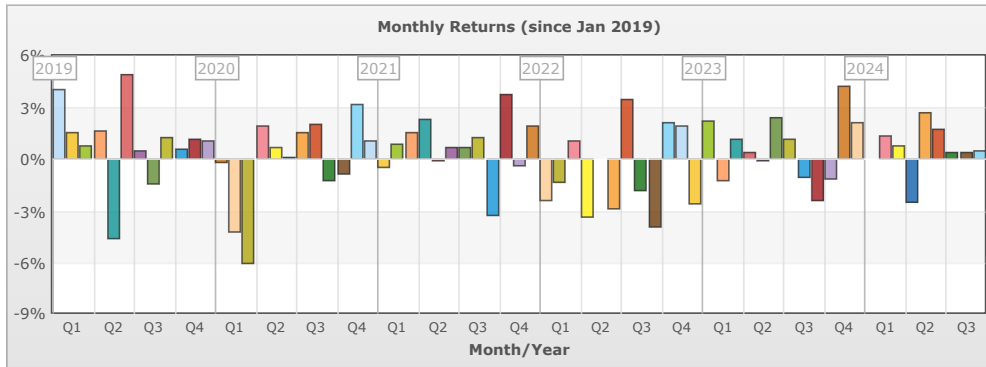
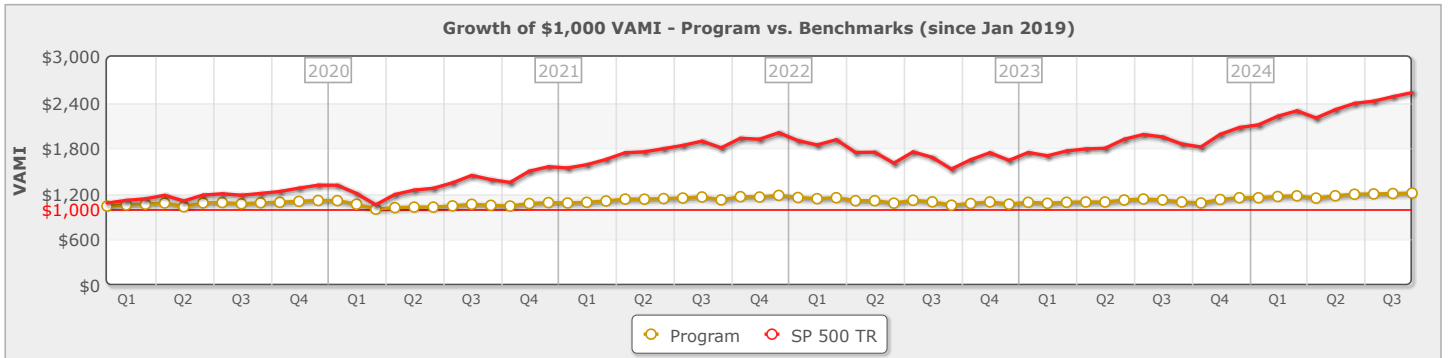
