

This means there are no lagging indicators outside of maybe a couple of moving averages to help identify dynamic support and resistance areas and trend. Whilst economic data and other global news events are the catalysts for price movements in a market, we don't need to analyze them to trade the market successfully. The reason is pretty simple; all economic data and world news that causes price movement within a market is reflected via price action on a market's price chart.








