Program Description: Neutral-A is an extension of Neutral, and augments Neutral by collecting the risk-free interest rate on unused cash required as collateral. Since February 2023, Neutral-A added box spreads on S&P 500 futures on top of Neutral to generate extra "risk-free" profits of about 4% per year. A box spread is a market risk-free option arbitrage strategy designed to capture the risk-free rate.

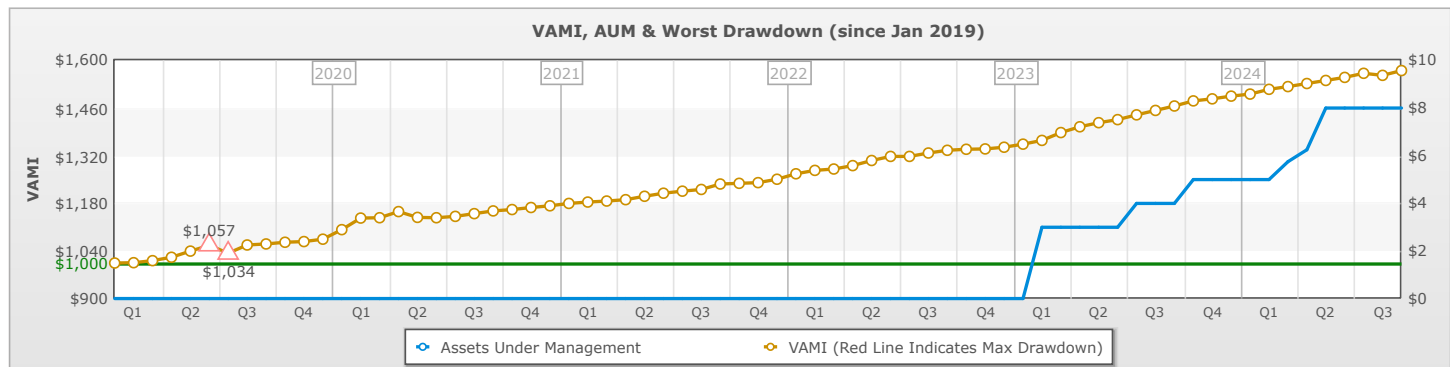
