



Program Description: Neutral Plus is an extension of Neutral, and augments Neutral by fully utilizing daily margin limits. After July 2022, Neutral Plus increases additional 0DTE spreads on expiration days. Since February 2023, the Neutral Plus also added box option spreads on S&P500 futures while generating extra profits. A box option spread is a "risk-free" arbitrage strategy to capture the benefits of Fed Funds interest rate.






