



Program Description: Chesapeake utilizes a technical program to trade more than 90 global markets. The system focuses on analyzing historical price movements within a quantitative framework rather than attempting to forecast changes through fundamental analysis. The strategies analyze large number of quantitative interrelated mathematical and statistical formulas. Charting techniques are utilized as a tool to identify key support and resistance levels as well as entry and exit points in the various markets. Chesapeake also analyzes price open interest, daily price action, volatility, volume, and market psychology or sentiment and limits the amount of equity committed to each trade, market, or complex.


