



**Program Description:** TThe J8 Redwood Strategy ("J8 RWS") is a fully systematic, higher frequency momentum strategy. It aims to deliver above-market returns with below-market volatility. The strategy uses quantitative models to analyze historical data for identifying and consistently exploiting market anomalies. It focuses on short-term patterns ranging from a few minutes to a few days. The asset allocation is risk-weighted and the portfolio is managed to a target volatility. The strategy trades highly liquid global futures markets across different time zones. Thereby, J8 RWS maintains non-correlation with traditional and alternative asset classes. J8 RWS uses the same long and short position signal engine as Andromeda but implements the said innovated risk management system. Andromeda was trading live from January 2015 until March 2024. J8 RWS is trading live since July 2024.




