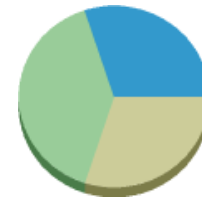

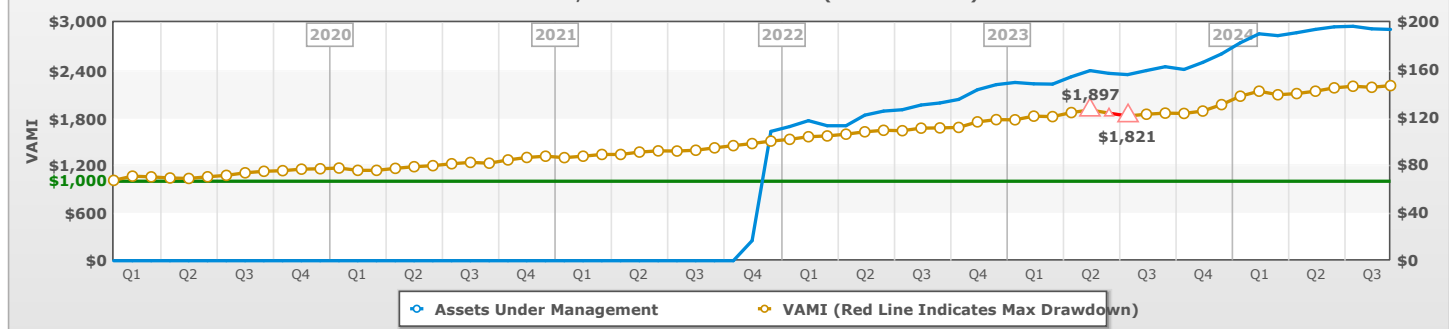


Market Segment

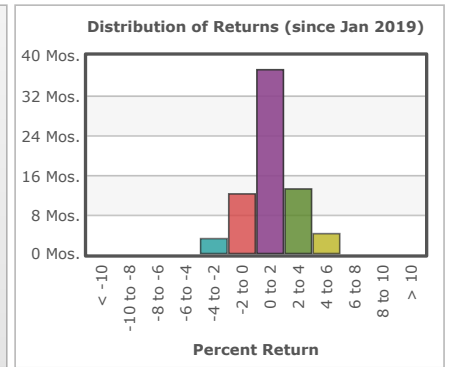
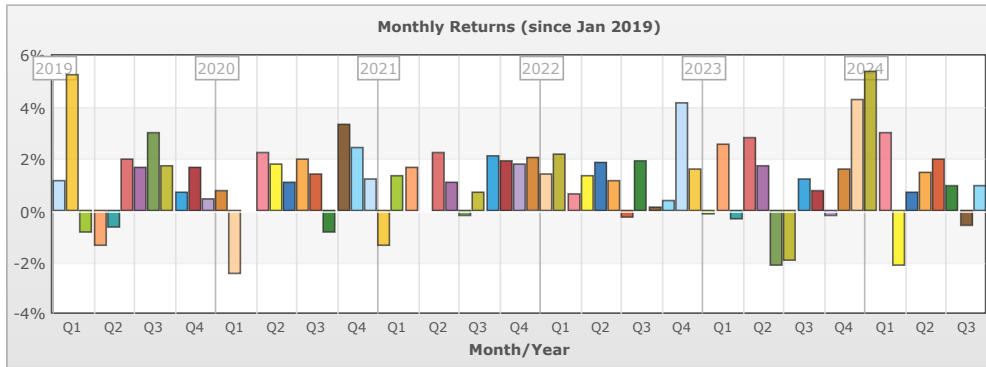
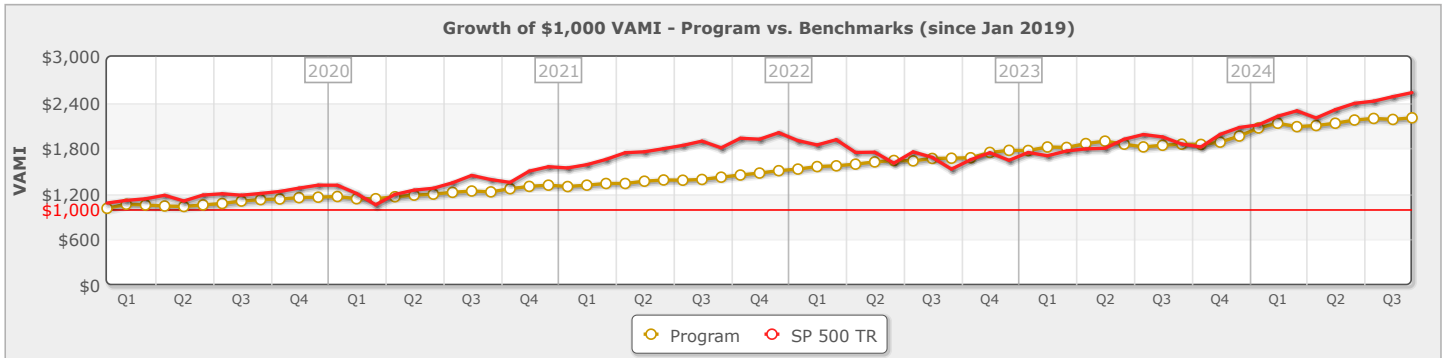
