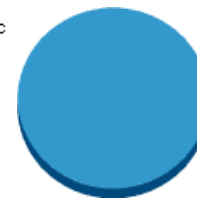

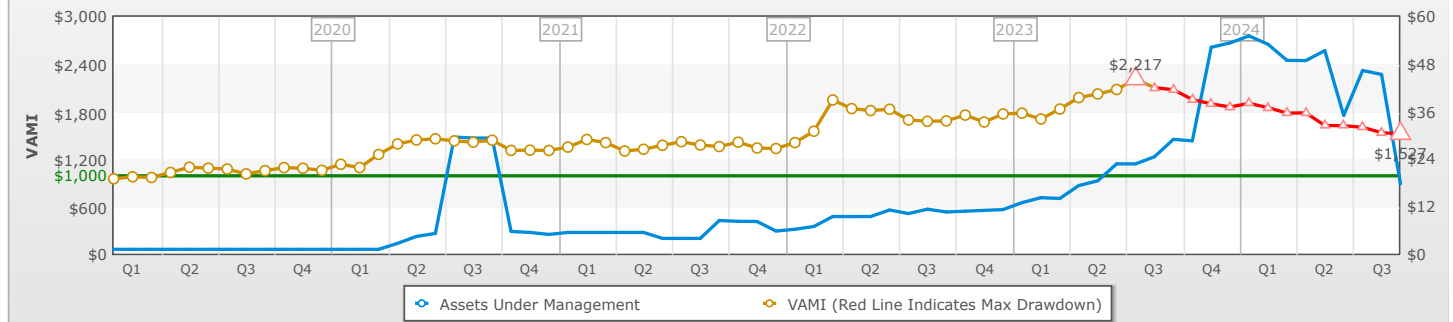


Market Segment

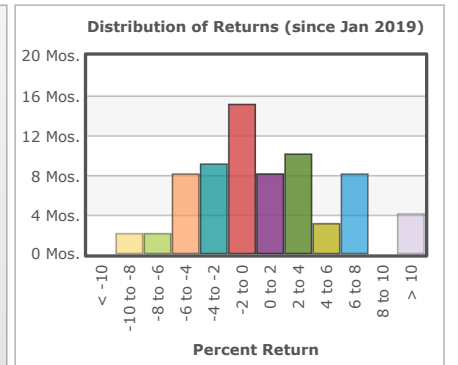
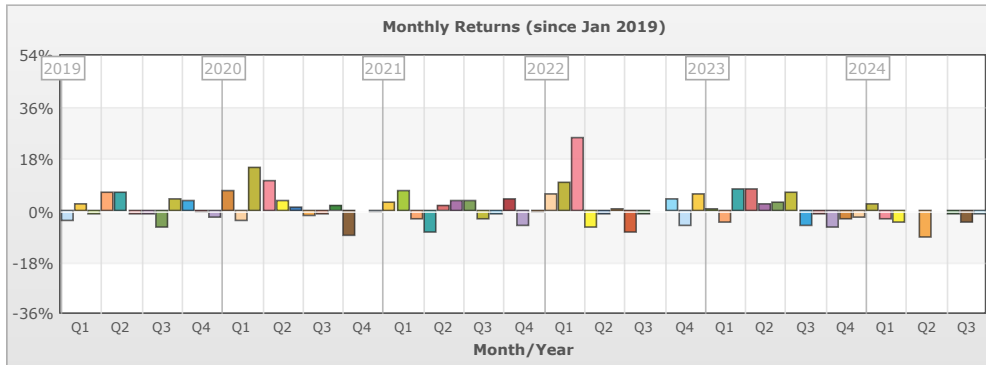
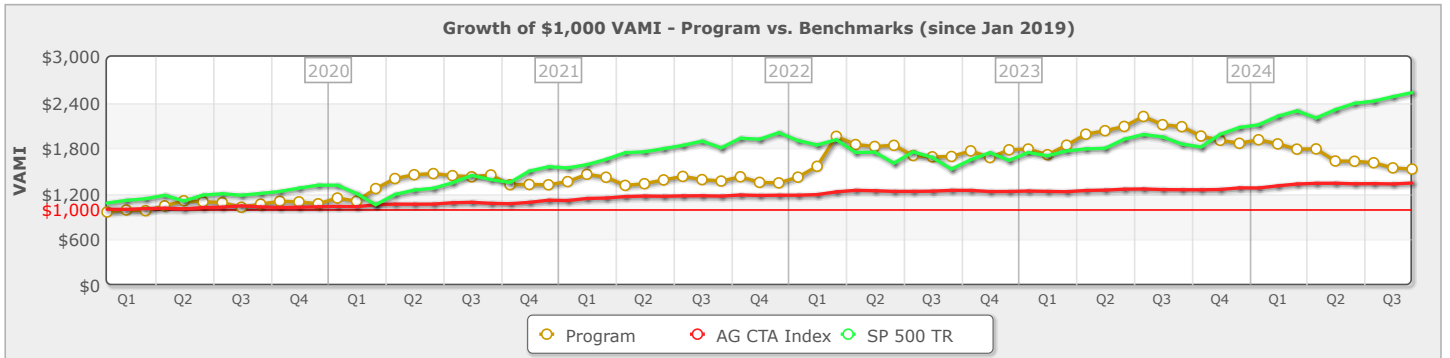
